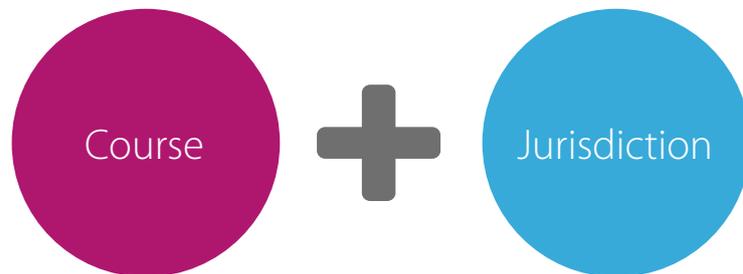

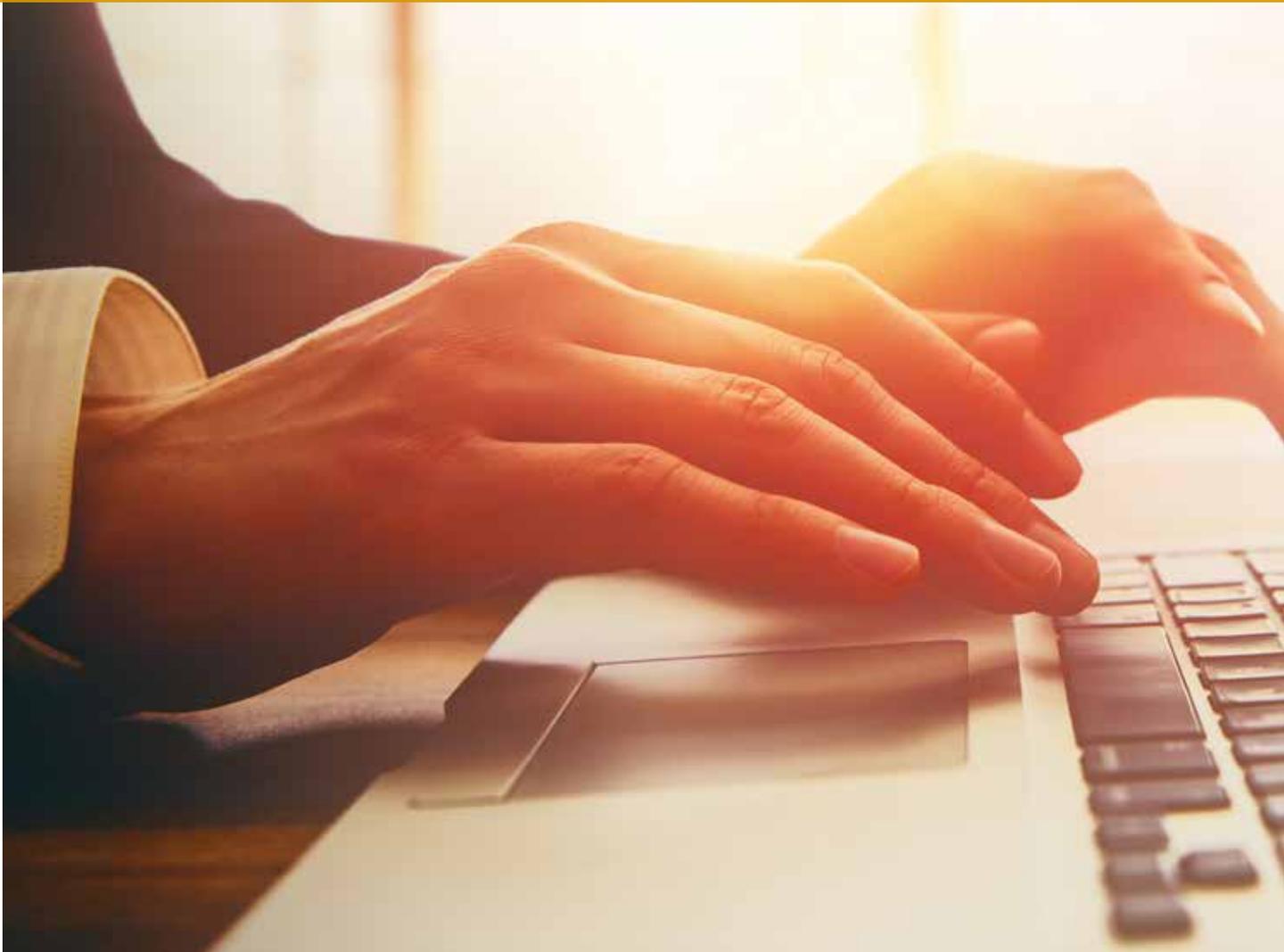

Certificate in Fund Administration

The **Certificate in Fund Administration** is suitable for those embarking on a career that involves fund administration, back office support or fund operations. The Certificate is made up of the following six modules:

- The Fund Industry
- Fund Structures
- Fund Strategies
- Fund Accounting and Fund Valuations
- Taxation
- Regulation

Structure

The **Certificate** is designed to be studied part-time, alongside professional commitments.

Delivery is via CLT International's new online learning platform using aspects of e-learning, video, podcast and text. This enables individuals worldwide to undertake this qualification.

In order to complete the Certificate, you must successfully pass an online multiple-choice-question

examination. We recommend that this is taken after three months of study but our flexible approach means that you can take the examination whenever you feel ready.

Cost

The Certificate course fee is £575 (+UK VAT if applicable). This fee is fully inclusive of access to our online learning platform, all course materials and examination fees.

Entry Requirements

The Certificate is open entry; however, applicants should have a good standard of literacy and be aware that the programme is delivered in English. We would recommend that those with more experience complete the Certificate prior to embarking on the Advanced Certificate or Diploma as these qualifications will build upon the knowledge covered in the Certificate.

Key Learning Outcomes

Upon successful completion of the Certificate in Fund Administration you will:

- have a sound understanding of the fundamental workings of the fund industry, including relevant terminology, and the roles and responsibilities of the different teams supporting a fund
- be able to identify and understand different fund structures and the documents relating to them

- be familiar with, and able to explain the differences between, various fund strategies
- be familiar with key terminology and processes in relation to accounting and valuations, and be able to carry out straightforward calculations
- understand the basic principles of the taxation of funds, including VAT and transfer pricing, and be able to carry out straightforward calculations
- understand the key regulation affecting fund administrators and the obligations placed upon the fund administrator by company law and AML provisions

Qualification

On completion of the course you will gain the Certificate in Fund Administration. If you complete a Specialist Jurisdictional Module, you will be awarded the Certificate in Fund Administration with the relevant specialism(s).

The **Advanced Certificate in Fund Administration** is an intermediate level programme suitable for experienced fund administrators and other back office support staff. This comprehensive course builds on the Certificate and takes a detailed, practical look at key aspects of fund administration and accounting.

The Advanced Certificate is made up of the following nine modules:

Part 1 - Advanced Fund Structures, Strategies and Regulation

- Key Parties in a Fund
- Fund Lifecycles
- Alternative Investment Funds, Fund of Funds and Debt Fund Considerations
- Advanced Regulation

Part 2 - Advanced Fund Accounting and Analysis

- Fundamentals of Fund Accounting
- Accounting for Specific Fund Transactions
- NAV, GAV and Key Fee Calculations
- Preparation and Interpretation of Financial Statements
- Advanced Taxation

Structure

The Advanced Certificate is designed to be studied part-time, alongside professional commitments.

Delivery is via CLT International's online learning platform using a combination of e-learning, video, podcasts and text. A live virtual classroom will be held for each part of the course and, in specified jurisdictions, a one-day revision session will be held prior to the final examination.

In order to complete the Advanced Certificate you must successfully complete a final closed-book examination at a centre local to you. The Advanced Certificate takes six months to complete.

Cost

The Advanced Certificate course fee is £1,200 (+UK VAT if applicable). This fee is fully inclusive of access to our online learning platform, all course materials, two live virtual classrooms, one day of tuition (or material covering the content if not in a face-to-face jurisdiction) and examination fees.

Entry Requirements

The Advanced Certificate is open entry but assumes a core base knowledge of the fund industry acquired through completion of the Certificate or a similar course of study/practical work experience.

All applicants should have a good standard of literacy and be aware that the programme is delivered in English.

Key Learning Outcomes

Upon successful completion of the Advanced Certificate in Fund Administration you will:

- have a detailed understanding of the functions of key parties in a fund and how they meet the needs of stakeholders
- understand the lifecycle of different fund structures, including the processes involved in their closure, winding down and liquidation
- be aware of the topical issues surrounding alternative investment funds, fund of funds and debt funds
- have a detailed knowledge of fund regulation and be able to interpret and apply Principal Documents, Scheme Particulars and investment restrictions
- understand the fundamentals of fund accounting and how to account for specific fund transactions

- be able to carry out a range of calculations in relation to a fund, including NAV, GAV, performance fees, and entry and exit charges.
- be able to calculate earnings per share and the total expense ratio, and use ratios to analyse a set of financial statements
- understand the impact of taxation on different fund structures and be able to carry out relevant tax calculations

Qualification

On completion of the course you will gain the Advanced Certificate in Fund Administration. If you complete a Specialist Jurisdictional Module, you will be awarded the Advanced Certificate in Fund Administration with the relevant specialism(s).
