Variation of workshop dates

Unfortunately, where several workshop dates are scheduled, we cannot guarantee that we will always be able to accommodate your requested date as sessions have a limited number of places to guarantee optimum teaching conditions and places are allocated on a first come, first served basis. However, if there are dates on which you are unable to attend due to prior commitments, we advise that you indicate these on your enrolment form so that we can avoid them as far as possible.

We advise that you check your booking confirmation email as soon as received and contact us if you have difficulty with the dates on which you have been registered.

Cancellation of workshops

On occasion there are insufficient enrolments for planned workshops to go ahead or a workshop date has to be changed. Where a workshop is cancelled, delegates will be notified of the cancellation (and offered attendance at an alternative centre) as soon as possible. For the first workshops this is once course enrolment has closed. For the second workshops this is after the first workshops have taken place (sometimes enrolments for second workshops are boosted by delegates from previous sittings re-joining the course).

It is **strongly recommended** that non-refundable travel/accommodation expenses are **not paid for in advance without checking with the CLTI office** the likelihood of the workshop in question going ahead. Travel/accommodation expenses incurred in relation to cancelled workshops or workshops where dates have been changed **will not** be reimbursed.

Fees

The course fee is £950 + VAT.
